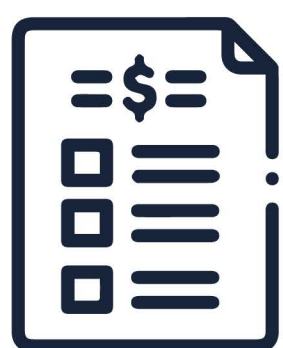




Legal Packages

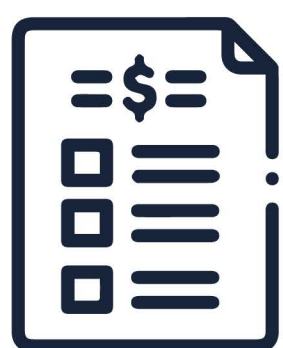


Legal Packages

Consultation Package

- Consultation package for legal consultations that spare entities the establishment of legal departments.
- Packages are tailored to the needs of entities requiring annual contract with limited, flexible consulting hours that are adaptable to the needs of the entity. It starts from 80 hours of consultation for small entities, 180 to 260 hours of consultation for medium-sized entities, and more than 260 hours of consultation for large entities.
- The package takes care of reviewing client's contracts and internal regulations, and managing contracts with partners, customers, Employees and case management



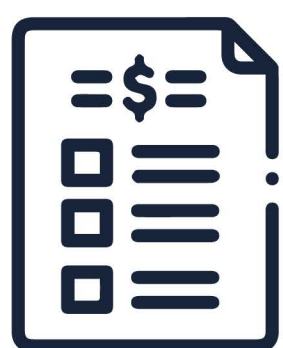

- Can be replaced with a higher package.



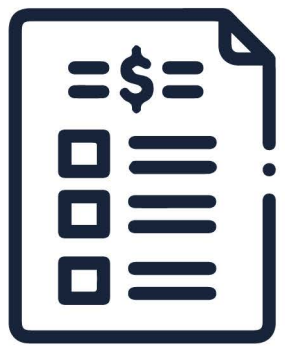


Legal Packages

- Multiple services that the client can choose what is appropriate, full or partial pleading or receiving legal support.
- Providing specialized workshops for the leadership and staff of clients in legal departments for not more than (15) training hours.
- Can be replaced with a higher package.



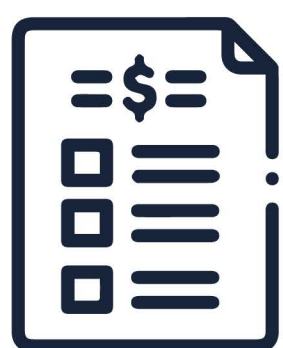


Legal Packages

Premium Package

- A package dedicated to medium and large entities to establish the entity, review the contracts and regulations thereof, manage contracts with partners, customers, employees, and manage cases with a claim of not more than 7 million riyals.
- Multiple services that the client can choose what is appropriate, full or partial pleading or receiving legal support.
- Providing specialized workshops for the leadership and staff of clients in legal departments for not more than (20) training hours.
- Can be replaced with a higher package.





Legal Packages

Special Package

- A package dedicated to family and business entities to establish such bodies, review contracts and regulations, contract management, agreements with family members, partners, customers, employees, and case management for cases with claims do not exceed 10 million riyals.
- Multiple services that the client can choose what is appropriate, full or partial pleading or receiving legal support.
- Providing specialized workshops for the leadership and staff of clients in legal departments for not more than (25) training hours.
- The hours allocated for this package can be increased to suit the actual need.

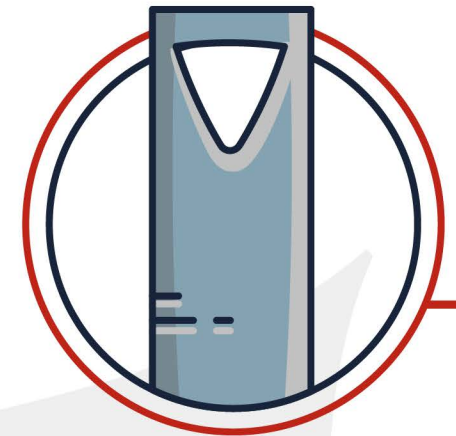
